



ONLINE REQUEST FOR DEFERRED DISPOSITION/PROBATION

I hereby enter my appearance to the offense of _____ Citation Number _____.
I understand that I have the right to a trial, and hereby waive my right to trial, plea NO CONTEST, and request the Court grant me an order deferring the disposition of my case.

I understand that with this request I must:

1. Submit a copy of my photo ID;
2. Submit a copy of my valid insurance listing me as a driver on the policy at the time of the violation if the violation is for failure to maintain financial responsibility;
3. Pay the court cost and deferred disposition fine portion of my violation.

I understand that the deferral period will end ninety (90) days from the date that this request is processed by the Court and during that time and before the end of that period I will:

1. No receive any new offenses,
2. Provide and maintain current contact information with the court for the duration of the deferral period, and
3. Abide by these additional conditions (as applicable)
 - a. Moving Violations – If you are less than 25 years old, you must complete a Driving Safety Course approved by the Texas Department of Licensing and Regulation (TDLR). The certificate MUST list Everman Municipal Court and will say "COURT COPY". Courses can be found here: <https://www.tdlr.texas.gov/driver/driver.htm>
 - b. Failure to Maintain Financial Responsibility – must maintain insurance during the deferral period. The Court will verify coverage. If your insurance changes, you must provide the Court with a new copy of your valid insurance listing the vehicle at the time of the violation as covered.

By signing below, **I AFFIRM THAT:**

1. I **DO NOT** have a commercial driver’s license (CDL) currently and did not have one at the time of the offense;
2. The offense was **NOT** committed in a construction zone with workers present;
3. I was **NOT** speeding more than 25 miles per hour over the posted speed limit;
4. I will pay all required fees and court costs assessed by the judge;
5. If I was under the age of 25 at the time of the offense and charged with a moving offense, I will be required to take a driver safety course;

Note: All requirements can be submitted or inquiries made in person by mail or email.

I also understand that failure to appear at the show cause hearing may result in a conviction being entered and reported to the Texas Department of Public Safety, the maximum fine and any remaining court costs will be due and a warrant may be issued for my arrest.
